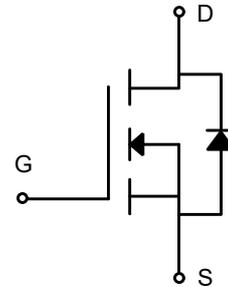

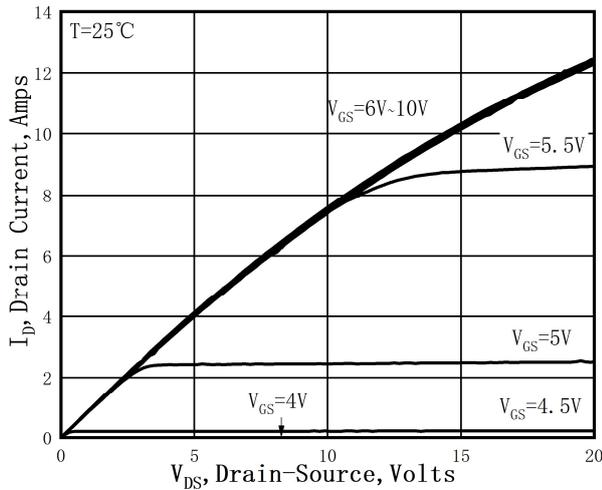


Figure 1. On-Region Characteristics

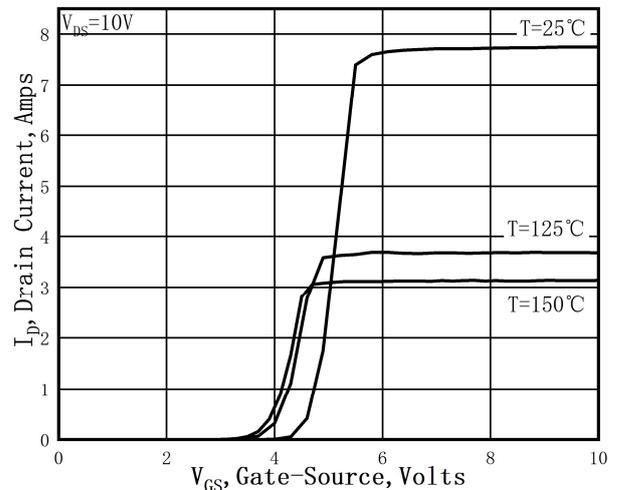


Figure 2. Transfer Characteristics

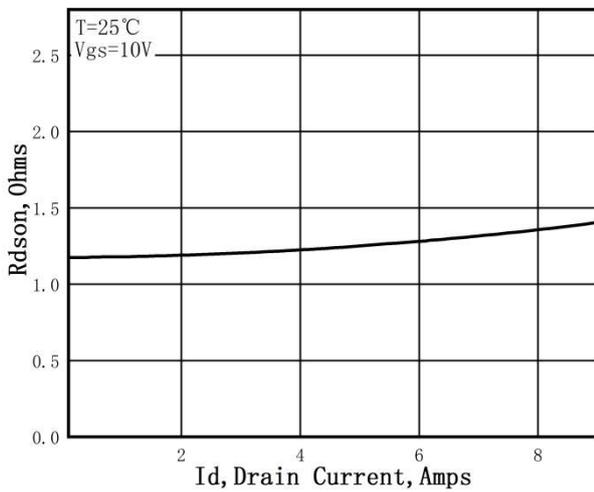


Figure 3. Drain Current vs. Temperature

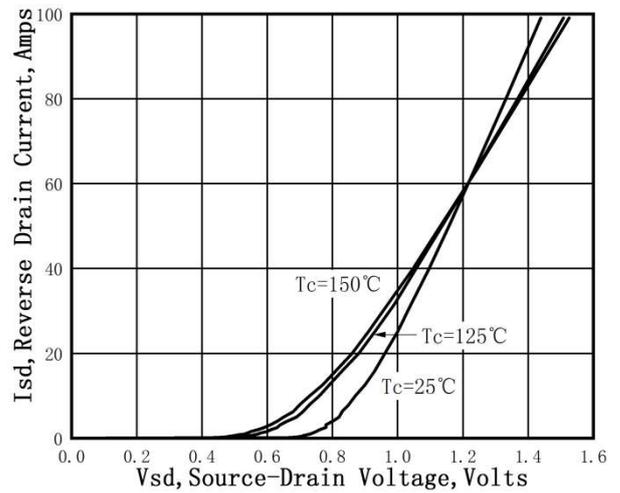


Figure 4. Normalized BV_{DSS} vs. Temperature

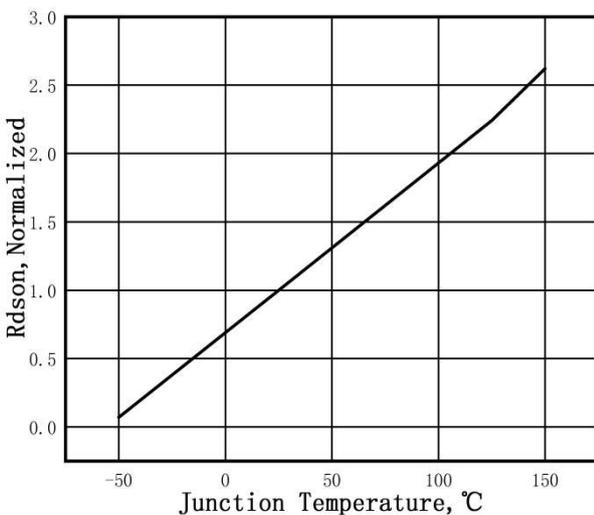


Figure 5. Capacitance Characteristics

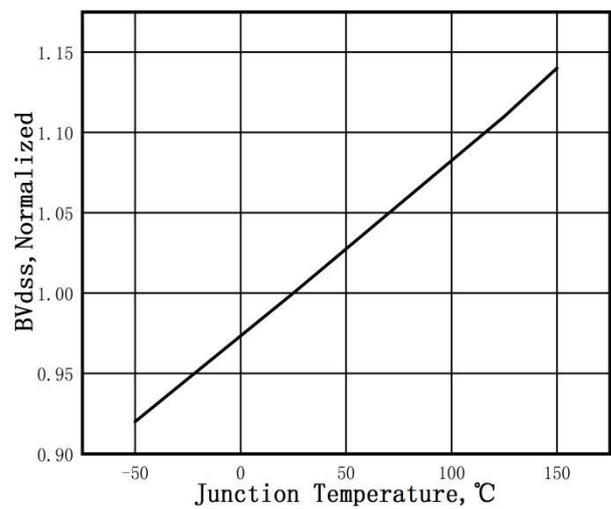


Figure 6. Gate Charge Characteristics

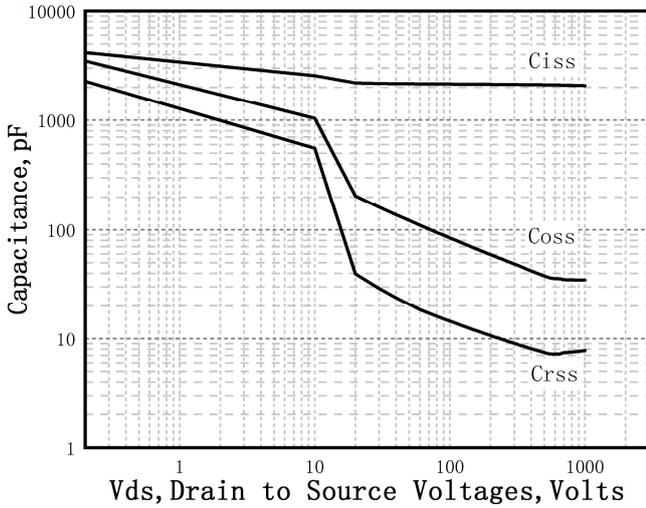


Figure 7. Normalized $R_{DS(on)}$ vs. Temperature

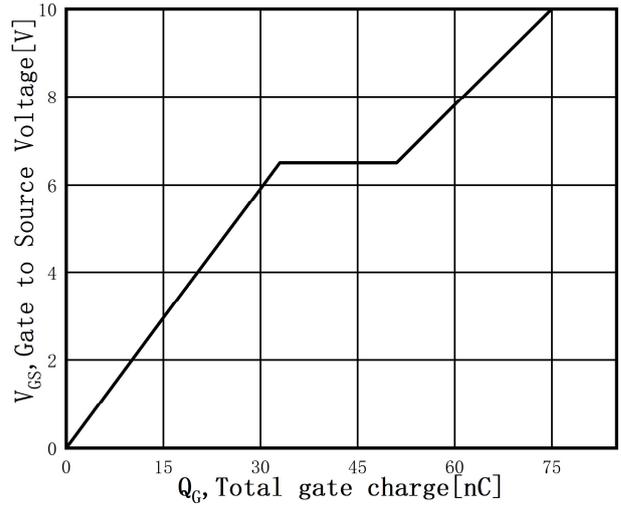


Figure 8. Typical Body Diode Transfer Characteristics

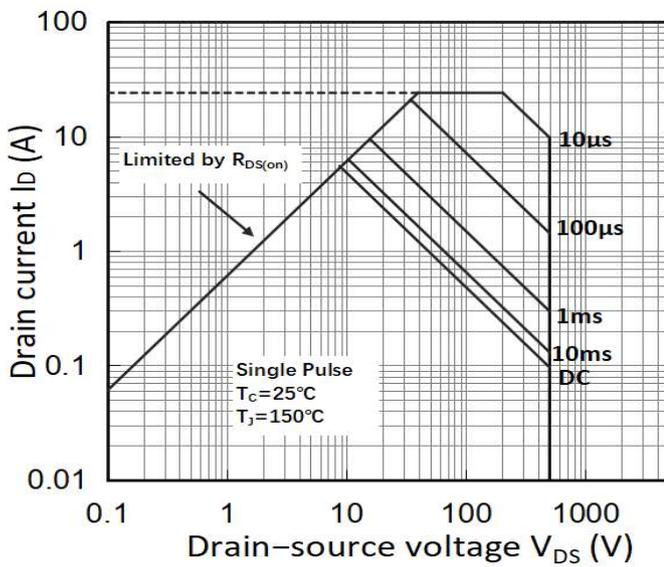


Figure 9. Maximum Safe Operating Area (TO-220F)

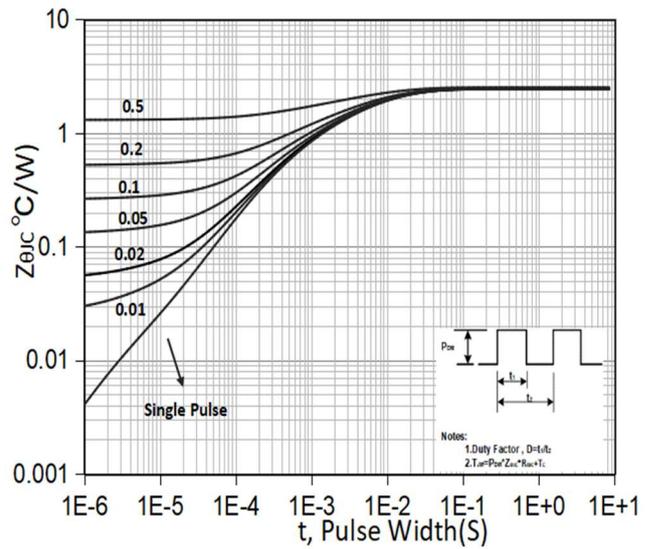
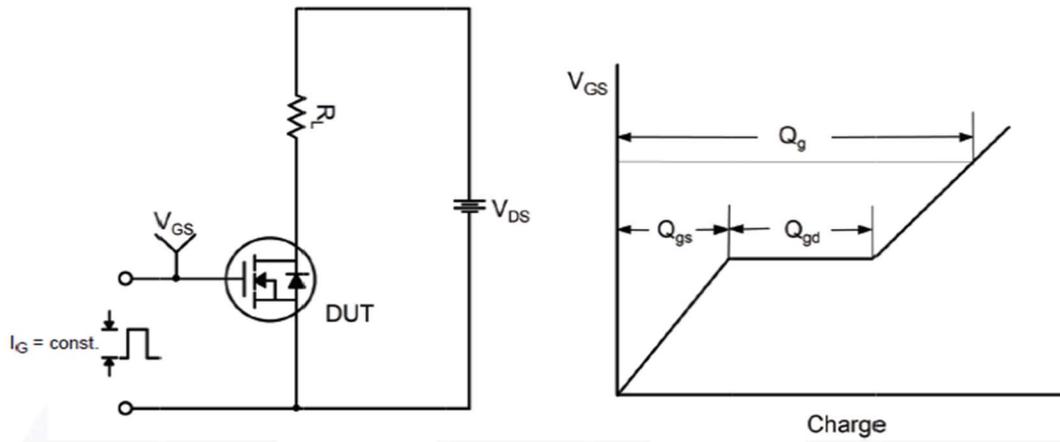


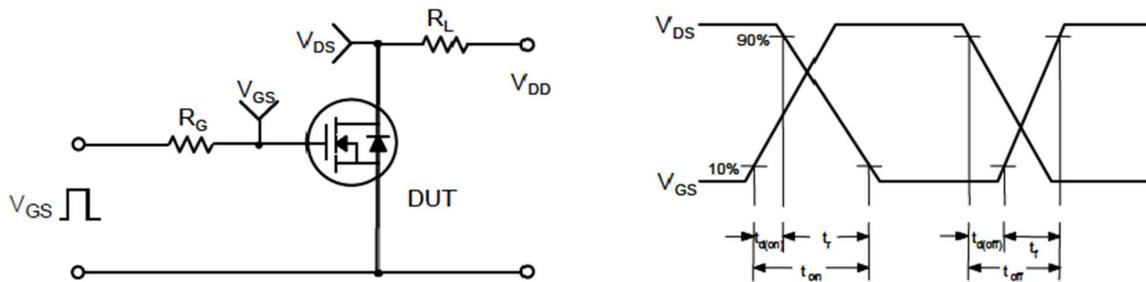
Figure 10. Transient Thermal Response Curve (TO-220F)

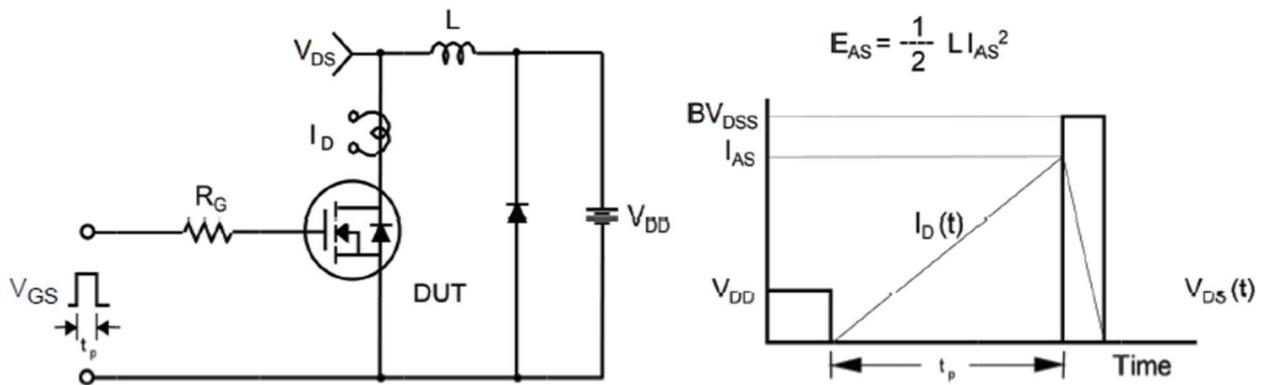
Gate Charge Test Circuit & Waveform



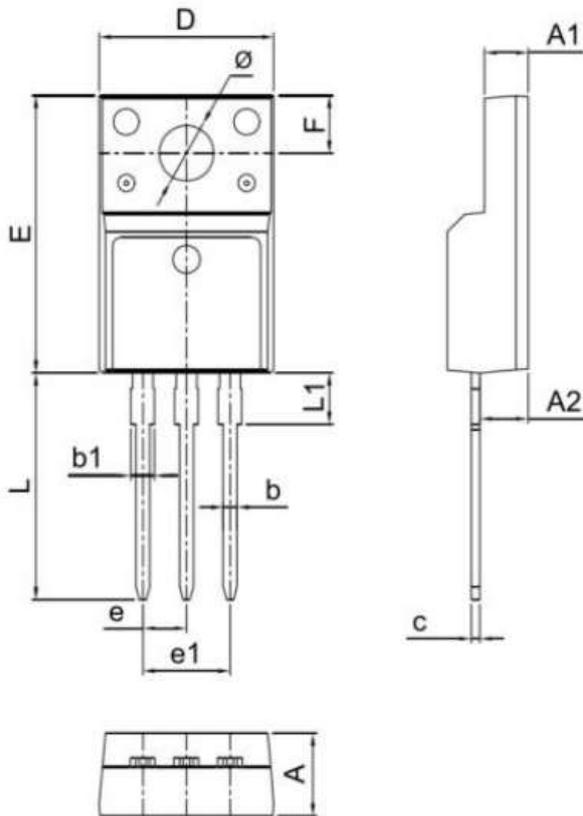
Switching Test Circuit & Waveforms
